

**WARRANTY TERMS AND CONDITIONS**

**From your contract**

In addition to any separate warranty that may be extended by the roofing materials manufacturer used on your job, Premier Roofing LLC, hereinafter referred to as "Contractor", warrants the work against roof leaks caused by defective workmanship for a period of time that is listed on your contract. If a defect covered by this warranty occurs resulting in a roof leak, Contractor will repair the roof leak and Contractor is held harmless for financial compensation or obligation to repair any damages inside of home during or after the scope of work. So Please; do not wait to call us, we are open 24/7. To obtain service under this limited warranty, a warranty claim must be submitted by going to Premier Roofings website at [www.PremierRoofingIdeas.com](http://www.PremierRoofingIdeas.com). This limited warranty covers roof leaks caused by defective workmanship only and does not include roof leaks caused by: (1) Obstruction or impairment of proper drainage of the roof by debris buildup, ice & snow buildup, structural "low spots", etc., that results in leaks caused by standing or ponding water; (2) Excessive walking on the roof and/or walking on the roof by persons who do so improperly; (3) Improper flashing or sealing of any penetrations made after the work done by Contractor has been completed (such as heating & air conditioning systems and ducts installed after Contractors work has been completed); (4) Any physical damage of whatever nature to the roof system; (5) Work done on the roof by persons other than Contractor. (6) Storm damage or other acts of God during or after the scope of work, Pipe flashing's will always be excluded from warranty after the first year. (7) If anyone other than Premier Roofing performs any work whatsoever on or around the Roof or area of work, this warranty will be deemed void and null. (8) Contractor has the right to suspend or cancel this warranty upon Inspection, and it has been determined that damage has occurred to the roof or any area under this warranty.

**NOTICE TO OWNER:** This limited warranty covers workmanship only and excludes all materials used. The roofing materials selected are NOT covered by this limited warranty and materials used to perform a warranty will be charged to customer at time of service. See the manufacturers warranty for details about warranties on the roofing materials. Owner is hereby informed that Contractor does not agree with or endorse the manufacturers warranty of the roofing materials. Consequently, Contractor shall not be held in any way responsible or liable for any defects in the roofing materials.
